

U.S. Military Administration of Cuba

The war between USA and Spain ended with the Paris treaty of 1898, Dec. 10. An U.S. military administration took place until 1902, May 20, when the first President of Cuba was elected.

An issue of provisional stamps, due to the lack of stamps, took place in Puerto Principe between December 1898 and January 1899: stamps of low denomination of the Spanish colony were surcharged with new values in U.S. currency, with types plates of five.
